## **Honorable Deb Matthews visits Project Hope!**

The visit was a happy one as the Hon Deb Matthews, along with Michael Barrett, CEO of the South West LHIN made an Ontario Community Funding announcement that allocated a \$109 Million investment in the health care sector. This investment includes \$38.5 million for increased home care, personal sup-

port, homemaking services and enhanced integration between hospitals and Community Care Access Centers. It also includes \$22 million in new priority funding for Ontario's Local Health Integration Networks (LHINs) to invest in local solutions to further address ALC (Alternate Level of Care) pressures. What does this mean for the people supported by Participation House Support Services? This investment will provide funding for day/night respite services to help families in our community.

For many families, who have members with complex needs, including those who are ventilator dependent or have other technological dependencies, their life depends on constant support and

often families are physically, mentally and emotionally exhausted. Participation House is delighted to receive a portion of this funding as it means we can provide day programs or individualized day supports and overnight respite services to this very vulnerable and under-served population and of course, the spinoff of this service is much needed respite for their families. Without respite from the on-going and demanding caregiver role, families can collapse and individuals end up in hospital or other inappropriate facilities. Also, individuals with complex care needs have a welcoming place in the community, where they can be engaged with others, have fun, socialize with peers and receive excellent and compassionate care

and support. While this funding will allow us to provide service to some individuals on health-funded

waiting lists, we are aware that others will continue to wait, and that the need persists as children and youth become adults. We want acknowledge and applaud the LHIN and the Ministry of Health for their efforts and commitment which have resulted in new resources to provide direct service to individuals with significant and complex care needs in our community.



# Tell us a little about your family and professional back-ground.

From birth at St. Joe's Hospital, I have enjoyed London for many years. 
